

Production Volumes in Billion Euro



Production Volumes in Billion US-Dollar






Global Ag Machinery export volume share for 2024 in %










Question: We expect our overall turnover within the next 6 months to....
















Question: We expect our overall **order intake** within the next 6 months to....






Question: Our volume of orders corresponds currently to a production period of ... months.



Question: Do you expect production stops due to shortages on the supplier side in the coming four weeks?






Turnover and Order Intake for Total AG Machinery


Turnover and Order Intake for Other AG Machinery

and non-adjusted indices



Order Intake in the last quarters in %






Order Intake for Tractors, Harvesting & Arable Equipment


Order Intake for Total AG Machinery from the German Market

without seasonal adjustment



Order Intake for Tractors, Harvesting & Arable Equipment from the German Market




